

Chap. 633. AN ACT MAKING APPROPRIATIONS FOR THE FISCAL YEAR NINETEEN HUNDRED AND SEVENTY-FIVE FOR THE MAINTENANCE OF BRISTOL COUNTY, ITS DEPARTMENTS, BOARDS, COMMISSIONS AND INSTITUTIONS, OF SUNDRY OTHER SERVICES, FOR CERTAIN PERMANENT IMPROVEMENTS, FOR INTEREST AND DEBT REQUIREMENTS, AND TO MEET CERTAIN REQUIREMENTS OF LAW AND GRANTING A COUNTY TAX FOR SAID COUNTY.

Be it enacted, etc., as follows:

SECTION 1. To provide for the maintenance of Bristol county, its departments, boards, commissions and institutions, of sundry other services, for certain permanent improvements, for interest and debt requirements, and to meet certain requirements of law, the following sums are hereby appropriated, subject to the provisions of law regulating the disbursement of county funds and the approval thereof, for the fiscal year nineteen hundred and seventy-five.

Chap. 634. AN ACT INCREASING THE SALARY OF THE CLERK OF THE THIRD DISTRICT COURT OF SOUTHERN WORCESTER.

Be it enacted, etc., as follows:

Section 79 of chapter 218 of the General Laws is hereby amended by striking out paragraph (1), as most recently amended by chapter 161 of the acts of 1974, and inserting in place thereof the following paragraph:—

(1) The clerks of the following courts shall be paid in accordance with the salary schedule as set forth in paragraph (2):
