Chap. 195. AN ACT MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE FISCAL YEAR NINETEEN HUNDRED AND EIGHTY-TWO FOR THE MAINTENANCE OF BERKSHIRE COUNTY.

Be it enacted, etc., as follows:

SECTION 1. To provide for supplementing certain items in the current appropriation act for Berkshire county, the following sums are hereby appropriated, subject to the provision of law regulating the disbursement of county funds and the approval thereof, for the fiscal year nineteen hundred and eighty-two.

SECTION 2. Notwithstanding any general or special law to the contrary, the treasurer of Berkshire county is hereby authorized with the approval of the county commissioners, to expend the total amount appropriated in section one from any available funds, including federal revenue sharing funds, in the treasury of the county.

Be it enacted, etc., as follows:

SECTION 1. To provide for supplementing certain items in the current appropriation act for the county of Dukes County, the following sums are hereby appropriated, subject to the provision of law regulating the disbursement of county funds and the approval thereof, for the fiscal year nineteen hundred and eighty-two.

SECTION 2. The county commissioners of the county of Dukes County are hereby authorized to levy as a county tax for the current fiscal year, in addition to the county tax previously authorized by chapter five hundred and forty-six of the acts of nineteen hundred and eighty-one, the total amount appropriated for the county of Dukes County in section one, less any funds received through the federal antirecession fiscal assistance program, the balance to be apportioned and assessed upon the several cities and towns of said county in the manner provided by law.

SECTION 3. This act shall take effect upon its passage.
