AN ACT MAKING CHANGES IN THE STATE SCHOLARSHIP PROGRAM.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Paragraph 22 of Section 1D of Chapter 15 of the General
2 Laws is hereby amended by striking out said paragraph and
3 inserting in place thereof the following new paragraph: —
4 The board may award full or partial scholarships to worthy
5 and qualified students who have been residents of the com-
6 monwealth for a period of four years immediately prior to
7 receiving such award and who are in need of financial assist-
8 ance in order to pursue a course of study in medicine or
9 dentistry. Recipients of scholarships shall be selected by the
10 Board. The Board shall award such scholarships and notify
11 all applicants on or before September first in each year. No
12 scholarships shall be awarded for more than five years to any
13 one student. In the event a student fails to complete his or
14 her studies, any unused balance of the scholarship shall be
15 returned to the General Fund. The board may expend such
16 sums as may be appropriated to carry out the provisions of
17 this paragraph.
