**AN ACT PERMITTING CITIES AND TOWNS TO ESTABLISH RECREATION
AND PARK SELF-SUPPORTING SERVICE REVOLVING FUNDS IN MUNICI-
PAL TREASURIES.**

*Be it enacted by the Senate and House of Representatives in General
Court assembled and by the authority of the same, as follows:*

- 1 Chapter 44 of the General Laws is hereby amended by in-
- 2 serting after section 53C the following section: —
- 3 *Section 53D.* In any city or town which accepts the pro-
- 4 visions of this section, all receipts received in connection with
- 5 the conduct of self-supporting Recreation and Park services
- 6 of said city or town shall be deposited in the treasury, shall
- 7 be kept in a separate fund by the treasurer apart from any
- 8 other of its monies, funds or other property, and the principal
- 9 and interest thereon shall be expended at the direction of the
- 10 authority, board, commission or official of said city or town
- 11 charged with said responsibility, without further appropria-
- 12 tion and only for the purpose of operating self-supporting
- 13 recreation and park services of said authority, board, com-
- 14 mission or official notwithstanding the provisions of section
- 15 fifty-three of this chapter. A city or town which has accept-
- 16 ed this section may, in like manner, revoke its acceptance.
