AN ACT TO ALLOW RETIREMENT CREDIT TO SAMUEL R. GARGANO, M.D.,
FOR SERVICE AS A CONSULTANT SURGEON.

Be it enacted by the Senate and House of Representatives in General Court assembled and by the authority of the same, as follows:

1 Notwithstanding any law or rule to the contrary regulating
2 the eligibility of the State retirement system, Samuel R.
3 Gargano, M.D., shall be credited with his service while em-
4 ployed as a consulting surgeon by the Solders' Home in Massa-
5 chusetts, from July 1, 1960, to December 29, 1974, provided he
6 pays to the retirement system such amounts as would have
7 been paid into the system had his payment during those years
8 been pursuant to an "01" account.
