AN ACT TO CLARIFY THE JURISDICTION OF THE DIVISION OF HEARING OFFICERS WITH RESPECT TO CONSTRUCTION CLAIMS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section thirty-nine Q (1) of chapter thirty of the
2 General Laws, as inserted by section sixty-two of chapter five
3 hundred seventy-nine of the acts of nineteen hundred and eighty, is
4 hereby amended by striking out the clause that begins said section
5 and immediately precedes subsection (a), and inserting in place the
6 following clause:—

7 *Section 39Q.* (1) Every contract awarded by any public agency
8 as defined by section thirty-nine A of chapter seven, and in accord-
9 ance with the provisions of either section forty-four A of chapter
10 one hundred forty-nine or section thirty-nine M of chapter thirty,
11 shall contain the following subparagraphs (a) through (d) in their
12 entirety:

1 SECTION 2. This act shall apply to all applicable contracts
2 awarded or executed on or after July first, nineteen hundred and
3 eighty-one.
