

By Mr. DiMasi of Boston, petition of Salvatore F. DiMasi for legislation to further define the powers and duties of the State Superintendent of Buildings. State Administration.

AN ACT TO FURTHER DEFINE THE POWERS AND DUTIES OF THE STATE SUPERINTENDENT OF BUILDINGS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 8 of the General Laws as most recently
2 amended by Chapter 579 of the Acts of 1980 by striking out
3 section 1 and inserting in place thereof the following sec-
4 tion: —

5 *Section 1.* There shall be within the division of capitol plan-
6 ning and operations a bureau of state buildings headed by a
7 state superintendent of buildings. The state superintendent of
8 buildings shall be appointed by the deputy commissioner of
9 capitol planning and operations with the approval of the com-
10 missioner of administration and may be removed only for just
11 cause in like manner. She/he shall report to the deputy com-
12 missioner of capitol planning and operations. Said superin-
13 tendent shall be a person of ability and experience and shall
14 devote his/her entire time to the duties of his/her office. Said
15 office shall not be classified under Chapter 31.

1 SECTION 2. The state superintendent of buildings and/or
2 the acting state superintendent of buildings shall maintain
3 all rights and privileges held immediately prior to July 1, 1981.

1 SECTION 3. Section 4 of Chapter 1004 of the acts of 1971 as
2 most recently amended by chapter 579 of the acts of 1980 is
3 hereby amended by striking out in line 1 the words "The
4 superintendent of state office buildings" and inserting in place
5 thereof the words "The state superintendent of buildings."

1 SECTION 4. Section 4A of Chapter 8 of the General Laws
2 as most recently amended by Chapter 579 of the Acts of 1980
3 is hereby amended by striking out in line 1 the words "The
4 superintendent of state office buildings" and inserting in place
5 thereof the words "The state superintendent of buildings."

1 SECTION 5. Section 4B of Chapter 8 of the General Laws as
2 most recently amended by Chapter 579 of the Acts of 1980 is
3 hereby amended by striking out in line 1 the words "the super-
4 intendent of state office buildings" and inserting in place there-
5 of the words "the state superintendent of buildings."

1 SECTION 6. Section 6 of Chapter 8 of the General Laws as
2 most recently amended by Chapter 579 of the Acts of 1980 is
3 hereby further amended by striking out the words "superin-
4 tentent of state office buildings" and inserting the words "state
5 superintendent of buildings."

1 SECTION 7. Section 9 of Chapter 8 of the General Laws as
2 most recently amended by Chapter 579 of the Acts of 1980 is
3 hereby further amended by striking out the words "superin-
4 tentent of state office buildings" and inserting the words "state
5 superintendent of buildings."

1 SECTION 8. Section 10 of Chapter 8 of the General Laws as
2 most recently amended by Chapter 579 of the Acts of 1980 is
3 hereby further amended by striking out in line 19 the words
4 "the deputy commissioner of capitol planning and operations"
5 and inserting the words "the state superintendent of build-
6 ings."

1 SECTION 9. Section 16A of Chapter 8 of the General Laws
2 as most recently amended by Chapter 579 of the acts of 1980
3 is hereby amended by striking out the words "subject to the
4 approval of the deputy commissioner of capitol planning and
5 operations" and by inserting the words "subject to the ap-
6 proval of the state superintendent of buildings."

1 SECTION 10. Section 17 of Chapter 8 of the General Laws
2 as most recently amended by Chapter 579 of the Acts of 1980

3 is hereby further amended by striking out the words “deputy
4 commissioner of capitol planning and operations” and insert-
5 ing the words “state superintendent of buildings”.

1 SECTION 11. Section 17A of Chapter 8 of the General Laws
2 as most recently amended by Chapter 579 of the Acts of 1980
3 is hereby further amended by striking out the word “super-
4 intendent” and inserting the words “state superintendent of
5 buildings.”

1 SECTION 12. Section 17B of Chapter 8 of the General Laws
2 as most recently amended by Chapter 579 of the Acts of 1980
3 is hereby amended by striking out the word “superintendent”
4 and inserting the words “state superintendent of buildings.”

1 SECTION 13. Section 4 of Chapter 579 of the acts of 1980 is
2 repealed.

1 SECTION 14. Section 65 of Chapter 579 of the acts of 1980 is
2 hereby amended by striking out the first sentence and insert-
3 ing the following “the bureau of building construction is here-
4 by abolished.”
