## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Eighty-three.

AN ACT REQUIRING OWNERS OF MOTOR VEHICLES TO SUBMIT MOTOR VEHICLE INSURANCE "GOOD STANDING" CERTIFICATES AS AN ADDITIONAL PREREQUISITE TO OBTAINING PERIODIC MOTOR VEHICLE INSPECTION WINDSHIELD STICKERS AT OFFICIAL INSPECTION STATIONS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 7A of chapter 90 of the General Laws  
2 is hereby amended by inserting after the first sentence the  
3 following sentence: — Such inspection shall include and re-  
4 quire the submission by the owner of the motor vehicle or  
5 trailer being inspected of a written notice from his compulsory  
6 motor vehicle liability insurance carrier that said insurance is  
7 in good standing as of no more than thirty days prior to the  
8 periodic inspection, which notice shall be retained by the af-  
9 ficial inspection station as part of its records.

1 SECTION 2. Said chapter 90 is hereby further amended by  
2 inserting after section 34 O the following section: —  
3 *Section 34P.* Each insurance carrier of a compulsory mo-  
4 tor vehicle liability policy on a motor vehicle or trailer regis-  
5 tered in the commonwealth shall issue to each insured at  
6 least ten days prior to every periodic motor vehicle inspection  
7 required by the registry of motor vehicles a written notice de-  
8 scribing the insured motor vehicle or trailer, the name and  
9 address of the insured owner, and containing a certification  
10 that the motor vehicle or trailer so described is as of the date  
11 of said notice covered by such compulsory motor vehicle lia-  
12 bility policy.
