- **DEP Public Water Supply Layers** - 8/18/04
The DEP GIS Group has updated the following layers:

- **C21e Layer Updated** - 8/2/2004
DEP GIS Group has updated the [Tier Classified Chapter 21E Sites](#) datalayer. 18 sites were added, 80 sites were removed, and 24 sites had a change in status.

- **DEP Wetlands (1:12,000) Data Updated** - 7/23/2004
Data have been added and updated to the Connecticut, Deerfield, Farmington, Millers, South Coastal and Westfield watersheds. For more information, please see the [Datalayer Description](#) and, for areas with completed data development, the [Status Map](#).

- **Title 5 Layer Updated** - 7/23/04
Many tiles were modified to reflect updates to the DEP Wetlands (1:12,000) layer. Distribution of the layer is now by the Watershed Index (previously the layer was tiled by USGS Quad panels).

- **NPDWSA Layer Updated** - 6/16/04
DEP GIS Group has updated the [Non-Potential Drinking Water Source Area](#) datalayer.

New Layer

- [Shellfish Suitability Areas](#) - 6/24/2004
This new layer comprises polygons representing habitats suitable for ten species of shellfish along the coast of Massachusetts. The polygons delineate areas that are believed to be suitable for shellfish based on the expertise of the Massachusetts Division of Marine Fisheries (DMF), the opinion of local Massachusetts Shellfish Constables, and information contained in maps and studies of shellfish in Massachusetts.

A new MassGIS Data Viewer has been created to work with ArcGIS 9.0. In addition to a change in the coding structure, the new Data Viewer is being released in a dll file format. - [Mass.Gov DCR Watershed Protection Act Viewer](#) - 6/30/2004
This viewer can be used to find information on how the Watershed Protection Act (WsPA) affects parcels in the Quabbin, Ware and Wachusett watersheds. Users can search by city/town, sheet id and parcel id, or address. The Watershed Protection Act (WsPA) regulates land use and activities within critical areas of the Quabbin Reservoir, Ware River and Wachusett Reservoir watersheds for the purpose of protecting the quality of drinking water. - [Mass.Gov Massachusetts Real Property Sales Viewer](#) - 6/22/2004
This application, developed by the Department of Revenue in conjunction with MassGIS, maps real property sales (currently with data in the range of approximately 1999-2002). The application features selection and mapping of sales by municipality/region, property type, price, and date. Users may zoom to detailed map of sale location and identify sales for detailed information.

A modified version of the MassGIS Runtime Data Viewer may now be downloaded for use with local data.

MassGIS Online Mapping

Enhancements to OLIVER

Another round of fixes/enhancements to the Online Data Viewer, OLIVER has been completed. (http://maps.massgis.state.ma.us/massgis_viewer/index.htm)

- style typo in GenerateMapURL button results fixed (bug #22)
- new look and feel options menu (useful for Mac users) (bug #25)
- measure tool added (only feet available as units currently) (enhancement #25)
- right-click map to save as image added (only PNG type available currently) (enhancement #38)
- right-click highlighted GenerateMapURL output text to copy it added (enhancement #81)

We are creating a bug/enhancement database and will post it online soon.

Coming up: the ability to customize the type of image returned (indexed or paletted for example), the ability to download images, and more!

Another Way to Save a Map as an Image File

We are always interested in hearing ideas about how to enhance the functions of [OLIVER](#) and when the resources become available, we'll hopefully implement some of the more common requests. Please contact us with your ideas, suggestions, comments on OLIVER - we plan to update it as time allows! While Oliver allows for the ability to print maps or save to a URL, it does not allow for a download of the map as a file. One work around is to do a screen capture using the following method.

Windows-based Screen Captures Only

1. Optimize the screen display by getting the maximum colors and highest resolution the computer can comfortably handle.
2. Close all but the target application (OLIVER) and hide the taskbar.
3. Open Windows Paint by going to Start >Programs>Accessories.
4. Make sure the scrollbars in the Paint window are pushed completely to the left and top of the screen.
5. Minimize Paint.
6. With the target application open, adjust the colors and placement of objects in application window.
7. Hit the Control and print screen buttons together. An image of the screen is now on the system clipboard.
8. Open Paint and paste the image in a blank window.
9. Crop and clean up the image.
10. Save the image with 24-bit color as bitmap (.BMP) format file.

This method will give you everything on your screen, including tool bars, clock, and all marginalia. Use Paint to clip out what you need.

Open Space Corner

The update of OpenSpace is progressing onwards. EOEA agency editors are currently updating OpenSpace in the new versioned SDE environment. Once the OpenSpace Webpage is updated and the integration of the new data schema with Oliver and the DataViewer is complete, these changes will be made public. Please check the MassGIS website for the upcoming release in the near future.

MassGIS Protected and Recreational OpenSpace and Commonwealth Capital:
As many of you may well be aware, a portion of the scoring for the Commonwealth Capital application depends on the level of Protected OpenSpace in a municipality. This number is determined by calculating for each town the ratio of acres of permanently protected OpenSpace as recorded by MassGIS to the area of the town itself. Keep in mind that our data contains much more than just land protected in perpetuity (LEV_PROT = 'P') and therefore, not all OpenSpace is included in this calculation.

What is OpenSpace and what is protected OpenSpace? In general, protected OpenSpace is any land held by an EOEA agency (e.g. DCR or DFG), Federal "Conservation" entity (e.g. USFWS or NPS), or Land Trust/Conservation Organization (e.g. Mass Audubon); municipal land where the deed states care and control is held by the Conservation Commission, Parks/Rec Dept, or Water Dept. (Watershed land); or any land with a recorded Restriction signed by the Secretary of Environmental Affairs (e.g. CR) or an EOEA Agency (e.g. CR or APR). Most other lands are considered to be of lesser protection, but naturally there are always exceptions. OpenSpace does NOT include developed property (e.g. a school building) or vacant land (e.g. undeveloped tax-title / donated land that is not given to a town agency as stated above) When in doubt, check the deed.
