AN ACT RELATIVE TO THE PUBLIC EMPLOYEE LABOR RELATIONS ACT.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 8 of Chapter 150E of the General Laws, as most
- 2 recently amended by Section 39 of Chapter 393 of the Acts of
- 3 1978, is hereby amended by deleting the second sentence and
- 4 inserting in place thereof the following sentence:
- 5 In the absence of such grievance procedure, binding arbitra-
- 6 tion may be ordered by the commission upon the request of
- 7 either party; provided that any such grievance procedure shall,
- 8 wherever applicable, be exclusive and shall supersede any
- 9 otherwise applicable grievance procedure provided by law;
- 10 and further provided that binding arbitration hereunder shall
- 11 be enforceable under the provisions of chapter one hundred
- 12 and fifty C and shall, where such arbitration is elected by the
- 13 employee as the method of grievance resolution, be the ex-
- 14 clusive procedure for resolving any such grievance involving
- 15 suspension, dismissal, removal or termination notwithstanding
- 16 any contrary provisions of sections thirty-nine and forty-one
- 17 to forty-five, inclusive, of chapter thirty-one, section sixteen
- 18 of chapter thirty-two, sections forty-two to forty-three A, in-
- 19 clusive, of chapter seventy-one or section ninety-nine of chap-
- 20 ter two hundred and seventy-six.
