By Mr. Costello, a petition (accompanied by bill, Senate, No. 1382) of Nicholas J. Costello and Larry F. Giordano for legislation to direct the Division of Capital Planning and Operations to convey a certain parcel of land in the town of Methuen under the control of the Department of Public Works to Joseph Kazanjian. AN ACT DIRECTING THE DIVISION OF CAPITAL PLANNING AND OPERATIONS TO CONVEY A CERTAIN PARCEL OF LAND IN THE TOWN OF METHUEN UNDER THE CONTROL OF THE DEPARTMENT OF PUBLIC WORKS TO JOSEPH KAZANJIAN.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 The division of capital planning and operations is hereby
2 authorized and directed to convey to Joseph Kazanjian for the
3 consideration of one dollar a certain parcel of land located on
4 Merrimac street in the town of Methuen consisting of 0.13 acres,
5 more or less, and shown as parcel 19-4 of the "Commonwealth
6 of Massachusetts Plan of Roads in the town of Methuen, Essex
7 County, laid out as a state highway by the department of public
8 works, October 31, 1961, scale 40 feet to the inch, layout number
9 5165", said land having been the land of Rose Kazanjian taken
10 by the department of public works under an order of taking for
11 an award of one dollar and recorded in the northern district
12 registry of deeds in the county of Essex of November 15, 1961
13 in Book 948 at page 493.

- 3 consideration of one dollar a certain parcel of land located in
- 4 the town of Danbury, Connecticut, and to the
- 5 town of Danbury, and there to grant 10-1 of the 10-1 acre parcel
- 6 of Massachusetts Plan or Book in the town of Danbury, Conn.
- 7 County, said lot to a wife singly, to be conveyed to her
- 8 wife, October 31, 1961, with or without the usual covenants
- 9 and conditions, and that the said 10-1 acre parcel be
- 10 by the department of public works, and to be used for
- 11 the purpose of one dollar and so on for the number of
- 12 copies of deeds in the county of Danbury, Connecticut, 1958
- 13 in that 10-1 acre parcel.
