AN ACT AUTHORIZING THE SOUTH MIDDLESEX REGIONAL VOCATIONAL TECHNICAL SCHOOL DISTRICT TO PAY FIFTY PERCENT OF THE PREMIUM FOR GROUP HEALTH INSURANCE FOR CERTAIN RETIRED TEACHERS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 The South Middlesex Regional Vocational Technical School  
2 District, acting by and through its School Committee, is hereby  
3 authorized to enter into an Agreement with the South Middlesex  
4 Regional Vocational Technical Teachers Association, which  
5 Agreement may become a part of the Collective Bargaining Agree-  
6 ment between said Committee and said Association, that the South  
7 Middlesex Regional Vocational Technical District may pay fifty  
8 percent of the premium actually paid for group health insurance by  
9 teachers who have; retired directly from the South Middlesex  
10 Regional Vocational Technical School District, are receiving a  
11 pension or annuity allowance from the teachers retirement system,  
12 have attained the age of fifty-five years and have served for a  
13 minimum of ten years in the South Middlesex Regional Vocational  
14 Technical School District.
