AN ACT

For the Better Protection of Mortgagors.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Chapter two hundred and sixty-six of the
- 2 General Laws is hereby amended by inserting after sec-
- 3 tion thirty-one the following section: Section 31-A.
- 4 Whoever, being the holder of a mortgage of real estate
- 5 which has been sold on foreclosure for the payment of
- 6 the mortgage, fails to pay over to the holder or holders
- 7 of the equity of redemption, including subsequent mort-
- 8 gagors of the mortgaged property, all proceeds of the
- 9 sale after deducting the reasonable costs thereof and the
- 10 principal and interest due on said mortgage, shall be 11 guilty of larceny.
- 1 Section 2. Section two of chapter two hundred and
- 2 sixty of the General Laws is hereby amended by striking
- 3 out the period at the end of line seven and inserting the
- 4 following: and except that actions in law or equity

- 5 by mortgagors or their legal representatives to recover
- 6 the proceeds of the sale of real estate sold under a power
- 7 of sale contained in the mortgage may be commenced
- 8 at any time.
- 1 Section 3. Section sixty-three of chapter two hun-
- 2 dred and seventy-seven of the General Laws is hereby
- 3 amended by inserting after the word "murdered", in line
- 4 two, the following: An indictment may be found or a
- 5 prosecution begun at any time after the commission of
- 6 the offense defined in section thirty-one A of chapter two
- 7 hundred and sixty-six.
- 1 Section 4. Chapter twelve of the General Laws is
- 2 hereby amended by inserting after section ten the follow-
- 3 ing section: Section 10-A. The attorney general or
- 4 his assistants shall at all times advise and assist mort-
- 5 gagors in the protection of their rights, and in his dis-
- 6 cretion, to protect a family home, the attorney-general
- 7 may, under chapter seventy-nine, take over the interest
- 8 of any mortgagee.
- 1 Section 5. Chapter one hundred and eighty-three of
- 2 the General Laws is hereby amended by inserting after
- 3 section seven the following new section: Section 7-A.
- 4 All mortgages hereafter written shall, at the option of
- 5 the mortgagor, be payable in monthly instalments equal
- 6 to the quotient of the amount of the mortgage divisible
- 7 by the number of months of the term thereof, plus the
- 8 interest accrued on the unpaid balance of the mortgage.
- 1 Section 6. Mortgagees shall stand in the same fidu-
- 2 ciary relation to mortgagors that a trustee now stands in
- 3 relation to a cestui que trust.
