The Commonwealth of Wassachusetts

In the Year One Thousand Nine Hundred and Twenty-Nine.

Resolve providing for the Investigation of the Duties and Compensation of Certain Officials, Judges and Employees of the Several Counties and of the Commonwealth, the Decline in the Purchasing Power of Money, and the Basis of Salaries paid in Private Employment.

Resolved, That an unpaid joint special committee, 2 to consist of one member of the senate to be designated 3 by the president thereof, three members of the house 4 of representatives to be designated by the speaker 5 thereof, and three members to be designated by the 6 governor, shall (1) consider and study the question 7 of the duties, salaries, fees, allowances and other 8 compensation of (a) the several judges, registers and 9 assistant registers of probate, the district attorneys, 10 the assistant district attorneys and deputy district 11 attorneys, and of (b) all appointive, elective county 12 officials and clerical staff, including the justices and 13 special justices of the several district and municipal 14 courts and the clerical assistants in the offices of the 15 several district attorneys, whose salaries and other 16 compensation are now paid, in whole or in part, by 17 the several counties; (2) compare, wherever possible, 18 the salaries and other compensation now paid to 19 persons in the employ of, or whose salaries and other 20 compensation are paid by, the various counties with 21 those now paid to persons occupying similar positions

22 or performing similar duties, and who are in the employ 23 of, or whose salaries and other compensation are paid 24 by, the commonwealth or by any city, and, in this 25 connection, consider and study the basis of salaries 26 as now paid in private employment; (3) report a 27 plan for classifying the positions held by such officials 28 and employees into services, groups and grades and 29 for standardizing salary rates and ranges; and, in 30 connection with such proposed classification, (4) con-31 sider with reference to the change in the purchasing 32 power of the dollar during the past ten years the 33 salary and any increases granted during said period. 34 As affecting the salaries and compensation payable 35 to registers and assistant registers of deeds and their 36 clerical assistants the committee shall consider the 37 advisability of a readjustment of the schedule of fees 38 collectible by the said registers. Said committee 39 shall report to the general court the results of its study 40 and its recommendations, together with drafts of 41 legislation necessary to carry the same into effect, 42 by filing the same with the clerk of the senate not 43 later than the first Wednesday of December in the 44 current year. Said committee shall have and may 45 exercise in regard to all officials, employees and 46 activities to which this resolve applies, the powers 47 granted by section eleven and twelve of chapter 48 seven of the General Laws, inserted therein by section 49 one of chapter three hundred and sixty-two of the 50 acts of nineteen hundred and twenty-three, in respect 51 to employment in the service of the commonwealth. 52 Said committee may, with the approval of the 53 governor and council, expend for expert, clerical and 54 other services and expenses such sums, not exceeding 55 five thousand dollars in the aggregate, as may here-56 after be appropriated.
