RESOLVE IN FAVOR OF THOMAS F. DALEY OF FALL RIVER.

1 *Resolved*, That for the purpose of discharging the
2 moral obligation of the Commonwealth in the premises
3 there shall be allowed to be paid out of the treasury
4 of the Commonwealth to Thomas F. Daley the sum
5 of \$323.56 on account of income taxes illegally assessed
6 against the said Thomas F. Daley. Said payment shall
7 be made without special appropriation therefor and
8 shall be charged against the general funds in the
9 treasury of the Commonwealth.
