AN ACT

Making Appropriations for sundry Charitable Expenses.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. The sums hereinafter mentioned
- 2 are appropriated, to be paid out of the treasury
- 3 of the Commonwealth, from the ordinary rev-
- 4 enue, for the purposes specified, to meet sundry
- 5 charitable expenses for the year ending on the
- 6 thirty-first day of December, in the year eighteen
- 7 hundred and ninety-one, to wit: -

STATE BOARD OF LUNACY AND CHARITY.

- 8 For expenses of the board of lunacy and char-
- 9 ity, including travelling and other expenses of
- 10 members, necessary legal expenses, and salary
- 11 and expenses of the clerk and auditor, a sum not
- 12 exceeding forty-five hundred dollars. [Pub.

- 14 For salaries and expenses in the department of

15 in-door poor, a sum not exceeding thirty-five 16 thousand five hundred dollars. [Pub. Stat., 17 chap. 79.]

18 For salaries and expenses in the department of 19 out-door poor, a sum not exceeding twenty thous-20 and dollars. [Pub. Stat., chap. 79.]

For salaries and expenses in the department 22 of the inspector of institutions, a sum not exceed-23 ing ten thousand dollars. [Pub. Stat., chap. 79.]
For travelling and other necessary expenses of 25 the auxiliary visitors of the state board of lunacy 26 and charity, a sum not exceeding fifteen hundred 27 dollars. [Pub. Stat., chap. 79.]

MISCELLANEOUS CHARITABLE.

28 For transportation of state paupers, a sum not 29 exceeding sixteen thousand dollars. [Pub. Stat., 30 chap. 86, sect. 22; Acts 1887, chap. 367.]

31 For the support and relief of state paupers in 32 state lunatic hospitals and asylums of the Com-33 monwealth, and of state lunatic paupers boarded 34 out in families, a sum not exceeding one hundred 35 and fifty thousand dollars. 47 hospital cottages for children at Baldwinsville, a

52 ninety-one and previous years, the same to

53 include cases of wife settlement, a sum not exceed-

56 For the burial of state paupers by cities and

57 towns, for the present and previous years, a sum

58 not exceeding ten thousand dollars. [Pub. stat.

61 wrecked seamen, by cities and towns for the pres-

62 ent and previous years, a sum not exceeding

65 For the support and transportation of unsettled

66 pauper infants, in this Commonwealth, including

67 infants in the infant asylums, a sum not exceeding

70 For expenses incurred in connection with small-

71 pox and other diseases dangerous to the public

72 health, a sum not exceeding three thousand dol-

73 lars, which is hereby made applicable for the
