While many people notice that computer monitors have a significant impact on the user's vision, few realize that the equipment they interact with everyday actually contains over 1,000 materials, many of which are highly toxic or have been linked to reproductive disorders or cancer.



The good news is that equipment models with fewer toxic components and monitors that are better for your eyes are now available from the new ITC16 statewide contract and will be increasingly easy to identify for purchase. Take an hour to come learn how to easily identify these models and protect your health and the environment with your next computer purchase!

## Cost-Effective and "Green" Initiatives at STAR 2005



Greening events is a popular topic these days: even the Democratic National Convention has implemented a variety of initiatives to reduce and recycle its waste and offset greenhouse gas emissions.

This year's STAR has developed a number of initiatives that promise to reduce its environmental impact. Many of these efforts also help OSD lower the cost of the event.

- Recycling will be provided for paper, bottles and cans as well as used attendee badges. Containers for the recycling program were donated by SCL-A1 Plastics, liners by The Bag Company.
- To reduce waste, china and reusable flatware (as opposed to disposable items) will be used to serve lunch.
- Leftover un-served food will be donated to area shelters by the DCU Center.
- All conference materials including promotional post-cards, posters and conference program were printed on recycled-content paper.
