

HOUSE No. 16.

[Bill accompanying the petition of Henry W. Eastham and others for legislation to authorize the Metropolitan Park Commission to erect and maintain a public bath-house and other buildings on lands taken for the Nahant Beach parkway. Metropolitan Affairs. Jan. 9.]

Commonwealth of Massachusetts.

In the Year One Thousand Nine Hundred and Three.

AN ACT

To authorize the Metropolitan Park Commission to build and maintain a Public Bath-house and Other Buildings required for Public Use on Nahant Beach.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The metropolitan park commis-
2 sion, created by chapter four hundred and seven
3 of the acts of the year eighteen hundred and
4 ninety-three, is hereby authorized and directed to
5 erect and maintain on the lands taken in Nahant
6 for the Nahant beach parkway a public bath-

7 house, and to provide in connection therewith
8 suitable accommodations for shelters and sani-
9 taries and for administrative purposes, and is
10 authorized to make such changes in the roadways
11 as may be rendered necessary thereby. Said
12 commission may establish rules and regulations
13 and make reasonable charges for the use of said
14 bath-house, and all sums received therefrom shall
15 be accounted for and paid to the treasurer and
16 receiver general of the Commonwealth and shall
17 be placed by him to the credit of the Metropolitan
18 Parks Expense Fund, and may be expended by
19 said commission in addition to any loans or ap-
20 propriations authorized for park purposes.

1 SECTION 2. To meet expenditures made under
2 authority of this act the treasurer and receiver
3 general, with the approval of the governor and
4 council, shall issue scrip or certificates of indebt-
5 edness, bearing interest at a rate not exceeding
6 four per centum per annum, to the amount of
7 seventy thousand dollars as an addition to the
8 Metropolitan Parks Loan, at such times and in
9 such sums as the metropolitan park commission
10 shall certify to him to be necessary to meet the
11 liabilities incurred by said commission under the
12 act aforesaid, and shall add to the existing sinking
13 fund to provide for the payment of the same.
14 Such scrip or certificates of indebtedness shall be
15 issued and additions to said sinking fund shall be
16 assessed and collected in accordance with the
17 provisions of section nine, ten, eleven and twelve

18 of said chapter four hundred and seven, and in
19 accordance with the provisions of chapter two
20 hundred and eighty-three of the acts of the year
21 eighteen hundred and ninety-five and of chapter
22 four hundred and nineteen of the acts of the year
23 eighteen hundred and ninety-nine.

1 SECTION 3. This act shall take effect upon its
2 passage.
