### AN ACT

Relative to the issuing of Bonds by the City of Brockton  
for the Construction of a High School Building.

*Be it enacted by the Senate and House of Representatives  
in General Court assembled, and by the authority of the  
same, as follows:*

1 SECTION 1. Section three of chapter three hundred  
2 and ninety-three of the acts of the year nineteen hundred  
3 and three is hereby amended by striking out the words  
4 "one hundred and eighty," in the fifth and sixth lines,  
5 and inserting in place thereof the words:—two hun-  
6 dred; by striking out the word "three," in the tenth  
7 line, and inserting in place thereof the word:—four; by  
8 striking out the word "three," in the twelfth line, and  
9 inserting in place thereof the word:—four; by striking  
10 out the figures "1903," in the fourteenth line, and insert-

11 ing in place thereof the figures :— 1904 ; by striking out  
12 the word “ four,” in the fifteenth line, and inserting in  
13 place thereof the word :— five ; by striking out the word  
14 “ eighty,” in the sixteenth line, and inserting in place  
15 thereof the words :— one hundred ; by striking out the  
16 figures “ 1904,” in the nineteenth line, and inserting in  
17 place thereof the figures :— 1905 ; by striking out the  
18 word “ three,” in the twenty-fourth line, and inserting in  
19 place thereof the word :— four ; by striking out the  
20 word “ four,” in the twenty-seventh line, and inserting  
21 in place thereof the word :— five ; by striking out the  
22 word “ four,” in the twenty-eighth line, and inserting in  
23 place thereof the word :— five ; by striking out the word  
24 “ four,” in the twenty-ninth line, and inserting in place  
25 thereof the word :— five ; and by striking out the word  
26 “ five,” in the thirty-second line, and inserting in place  
27 thereof the word :— six, — so as to read as follows :—

28 *Section 3.* For the purpose of carrying out the work  
29 specified in said order and in this act, the city treasurer  
30 of said city is hereby authorized and directed, from time  
31 to time, upon the request of said commission, as herein-  
32 after provided, to borrow the sum of two hundred thou-  
33 sand dollars and to issue bonds, notes or scrip of the city  
34 to that amount, at the times and in the manner following,  
35 to wit: the indebtedness to be incurred hereunder  
36 during the year nineteen hundred and four shall not ex-  
37 ceed the sum of one hundred thousand dollars; the  
38 bonds, notes or scrip issued therefor shall be dated May  
39 first, nineteen hundred and four, and shall be denom-  
40 inated on their face, “ Brockton High School Loan,  
41 1904.”

42 The indebtedness to be incurred hereunder in the year  
43 nineteen hundred and five shall not exceed one hundred  
44 thousand dollars, and the bonds, notes or scrip to be

45 issued therefor shall be dated May first, nineteen hundred  
46 and five, and shall be denominated on their face, “ Brock-  
47 ton High School Loan, 1905.”

48 The securities authorized to be issued hereunder shall  
49 be signed by the mayor and city treasurer, and shall bear  
50 interest at a rate not exceeding four per centum per annum,  
51 payable semi-annually. The issue of the year nineteen  
52 hundred and four shall be paid in twenty annual propor-  
53 tionate payments of not more than five thousand dollars  
54 each, and the first of said payments shall be made on the  
55 first day of May, in the year nineteen hundred and five.  
56 The issue of nineteen hundred and five shall be paid in  
57 twenty annual proportionate payments of not more than  
58 five thousand dollars each, and the first of said payments  
59 shall be made on the first day of May, in the year nine-  
60 teen hundred and six.

1 SECTION 2. So much of said chapter three hundred  
2 and ninety-three of the acts of the year nineteen hundred  
3 and three as is inconsistent herewith is hereby repealed.

1 . SECTION 3. This act shall take effect upon its passage.
