AN ACT

Making Appropriations for the Salaries and Expenses of the Massachusetts Bureau of Prisons.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. The sums hereinafter mentioned
- 2 are hereby appropriated, to be paid out of the
 - 3 treasury of the commonwealth from the ordinary
 - 4 revenue, for salaries and expenses of the Massa-
 - 5 chusetts bureau of prisons, for the fiscal year end-
 - 6 ing on the thirtieth day of November, nineteen
 - 7 hundred and seventeen, to wit: -
 - 8 For the salary of the director, six thousand dol-

1 Section 2. This act shall take effect upon its 2 passage.
