The USDA third party audit process will be discussed as well as strategies for controlling potentially microbial food safety risks from farm to fork. Rich Bonanno, PhD, UMass Extension Education and Co-PI, for the UMASS GAP Project will be the main presenter. The cost is \$50 and includes a GAP Manual and CD with templates for GAP records. Additional employees may attend for \$10 and receive the training but not the manual. Dr. Hashemi is an agronomist/crop physiologist and currently serves as the team leader of "crop, dairy, livestock, and equine team" of UMass Extension. He has assisted dairy, livestock, and horse owners for more than ten years with nutrient and manure management.
