AN ACT EXTENDING STATE FINANCIAL ASSISTANCE TO CERTAIN URBAN RENEWAL PROJECTS TO BE REDEVELOPED FOR RESIDENTIAL RE-USES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Section 1. Chapter 121 of the General Laws is hereby

- 3 9 of chapter 776 of the acts of 1960, and inserting in place 4 thereof the following section:
- Section 26GGG. The commonwealth, acting by and
- 6 through the division of urban and industrial renewal, may
- 7 contract with the cities and towns of the commonwealth,
- 8 acting by and through housing authorities or redevelopment 9 authorities, to provide financial assistance for residential,
- 10 commercial or industrial urban renewal and redevelopment
- 11 projects as authorized by the provisions of this chapter. Such
- 12 state financial assistance may be provided only for projects
- 13 which are to be redeveloped for residential, commercial or
- 14 industrial re-use, and which are ineligible for federal capital
- 15 grants under Title I of the Federal Housing Act of 1949, as
- 16 amended, or for which grants application has been denied.

- 3 of the acts of 1962, is hereby further amended by striking out,
