AN ACT REQUIRING THAT MILK CONTAINERS BE MARKED TO SHOW
THE DATE OF PACKAGING.

*Be it enacted by the Senate and House of Representatives in
General Court assembled, and by the authority of the same, as
follows:*

- 1 Chapter 94 of the General Laws is hereby amended by
- 2 adding after section 13E the following section:—
- 3 *Section 13F.* Any person selling milk graded and described
- 4 in the rules and regulations adopted and approved under
- 5 sections thirteen and thirteen A, or amended from time to
- 6 time under authority thereof, in addition to labelling as may
- 7 be required, shall state upon the package in which such milk
- 8 is contained the date on which the milk was packaged.
- 9 Whoever himself or by his servant or agent sells, offers for
- 10 sale, exchanges or delivers or has in his custody or possession
- 11 with intent to sell, offer for sale, exchange or deliver any
- 12 package containing milk which does not state the date on
- 13 which the milk was packaged shall be punished by a fine of
- 14 not more than fifty dollars.
