The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Seventy.

AN ACT PROVIDING THAT A DECREE FOR SEPARATE SUPPORT MAY REQUIRE THAT ONE OF THE PARTIES SHALL BE REQUIRED UNDER CERTAIN CIRCUMSTANCES TO MAKE A CONVEYANCE OF REAL PROPERTY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 209 of the General Laws is hereby amended by insert-
2 ing after section 32, the following section: —
3 *Section 32A.* Whenever a decree shall be made in a proceed-
4 ing for separate support or for desertion directing that a deed,
5 conveyance or release of any real estate or interest therein shall
6 be made, such decree shall create an equitable right to its en-
7 forcement subject to the provision for recording of notice in
8 section fifteen of chapter one hundred and eighty-four, in the
9 party entitled thereto by the decree, and if the decree has not
10 been complied within three months after the decree has been en-
11 tered and is thereafter recorded in the manner provided by sec-
12 tion forty-four of chapter one hundred and eighty-three, then
13 the decree itself shall operate to vest title to the real estate or
14 interest therein in the party entitled thereto by the decree as
15 fully and completely as if such deed, conveyance or release had
16 been duly executed by the party directed to make it.
