AN ACT CHANGING THE JOB GROUP CLASSIFICATIONS OF CERTAIN POSITIONS IN THE DEPARTMENT OF PUBLIC HEALTH, DIVISION OF PHYSICAL THERAPY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

3 and directed to re-allocate the position of physiotherapist in
4 the department of public health, division of physical therapy
5 from Job Group IX to Job Group XIII; the position of ortho-
6 pedic physiotherapist in said department from Job Group X to
7 Job Group XIV; the position of supervising physiotherapist in
8 said department from Job Group XII to Job Group XV; the
9 position of occupational therapist in such department from Job
10 Group IX to Job Group XIII; and the position of head occu-
11 pational therapist in said department from Job Group XII
12 to Job Group XV, as established in subdivision 1 of section
13 forty-six of chapter thirty of the General Laws, as most re-
14 cently amended by chapter five hundred and forty-seven of the
15 acts of nineteen hundred and sixty-nine.
