

By Mr. Tobin of Quincy, petition of Arthur H. Tobin and Philip N. Carney relative to the tax exemption granted to certain medical service corporations. Taxation.

The Commonwealth of Massachusetts

AN ACT RELATIVE TO THE TAX EXEMPTION ON CERTAIN MEDICAL SERVICE CORPORATIONS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 14 of chapter 176B of the General Laws
2 is hereby amended by striking out the last sentence and
3 inserting in place thereof the following sentence:—Every
4 corporation subject to this chapter shall pay annually to the
5 state a premium tax as required under section twenty-two of
6 chapter sixty-three of the General Laws and, as most recently
7 amended, under section eighteen of chapter five hundred and
8 forty-six of the acts of nineteen hundred and sixty-nine.

1 SECTION 2. Section 14 of chapter 176C of the General Laws
2 is hereby amended by striking out the first sentence and
3 inserting in place thereof the following sentence:—Every
4 corporation subject to this chapter is hereby declared to be a
5 charitable and benevolent corporation and will pay a pre-
6 mium tax annually to the state as required under section
7 twenty-two of chapter sixty-three of the General Laws and,
8 as most recently amended under section eighteen of chapter
9 five hundred and forty-six of the acts of nineteen hundred
10 and sixty-nine.

1 SECTION 3. The proceeds received by the commonwealth as
2 a result of the premium tax required under section twenty-
3 two of chapter sixty-three of the General Laws shall be used
4 for the establishment of guidance centers within the depart-
5 ment of mental health.
