MEMORANDUM OF THE SECRETARY OF THE COMMON-WEALTH PURSUANT TO GENERAL LAWS, CHAPTER 3, SECTION 7, WITH RESPECT TO PETITION OF ALBERT B. WOLFE RELATIVE TO CHANGING THE NAME AND CORPORATE PURPOSES OF THE TRUSTEES OF THE CHAPTER OF THE ALPHA DELTA PHI FRATERNITY IN WILLIAMS COLLEGE.

March 20, 1970.

To the Honorable Senate and House of Representatives.

The above-named petition was transmitted to me by the Clerk of the House of Representatives on January 8, 1970, with a request for a memorandum.

Trustees of the chapter of the Alpha Delta Phi Fraternity in Williams College was incorporated under the provisions of Chapter 54 of the Mass. Special Laws of 1880, which at was approved March 5, 1880. Chapter 135 of the Laws and Resolves of 1910 authorized the Trustees of the chapter of the Alpha Delta Phi Fraternity in Williams College to hold additional real and personal estate.

Section 1 of the bill before your honorable bodies recites that the Trustees of the Chapter of the Alpha Delta Phi Fraternity in Williams College incorporated by Chapter 54 of the Acts of 1880, may whenever there is no longer an undergraduate chapter or society of the Alpha Delta Phi Fraternity in Williams College, change its name to "Trustees of the Williams Alpha Delta Phi Fund" and continue to hold and manage the property said corporation then has or may thereafter receive or purchase, with the powers and privileges and subject to the duties, liabilities and restrictions set forth in the general laws which now are or may hereafter be in force relating to charitable corporations, for the

purpose of supporting by grants from income and principal scholarships, teaching and programs, in Williams College, compatible with the literary traditions of the Alpha Delta Phi Fraternity.

Please note that according to the records in this office the true name of the corporation is: Trustees of the chapter of the Alpha Delta Phi Fraternity in Williams College (the letter c in the word chapter being uncapitalized) not: Trustees of the Chapter of the Alpha Delta Phi Fraternity in Williams College (the letter c of the word chapter being capitalized) as the name appears in the petition.

It is respectfully suggested that the Trustees of the chapter of the Alpha Delta Phi Fraternity in Williams College file with the Office of the State Secretary the annual reports due the Commonwealth for the years 1968 and 1969, with an accompanying fee of

\$5 for each report, a total fee of \$10.

Special legislation is required to effect the desired result.

Whether or not this should be allowed is a matter of policy within your exclusive jurisdiction, and this office expresses no opinion on the merits of the bill. No fee is required to be paid by a corporation of this type under the provisions of Chapter 3, Section 7.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 4 ever there is no longer an undergraduate chapter or society of

- 6 its name to "Trustees of the Williams Alpha Delta Phi Fund"
- 7 and continue to hold and manage the property said corpora-
- 8 tion then has or may thereafter receive or purchase, with the
- 9 powers and privileges and subject to the duties, liabilities and
- 10 restrictions set forth in the General Laws which now are or
- 11 may hereafter be in force relating to charitable corporations,
- 12 for the purpose of supporting by grants from income and
- 13 principal scholarships, teaching and programs, in Williams
