AN ACT ESTABLISHING IN THE DIVISION OF EMPLOYMENT SECURITY A PLACEMENT BOARD FOR PAROLEES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 9N of chapter 23 of the General Laws is hereby
2 amended by adding after paragraph (b) the following para-
3 graph: —

4 (c) There shall be in the division a placement board for
5 parolees, consisting of three persons to be appointed by the
6 governor. The governor shall from time to time designate one
7 of the members as chairman. Of the members first appointed,
8 one shall be appointed for a term of two years, one for a term
9 of four years, and one for a term of six years, and thereafter
10 as the term of a member expires his successor shall be ap-
11 pointed for a term of six years. Vacancies shall be filled in
12 like manner for the remainder of the unexpired term. All
13 members shall serve until the qualification of their respective
14 successors. Each of the members of the board shall receive
15 the sum of forty dollars as compensation for each day's atten-
16 dance at meetings of the board; provided, however, that the
17 total amount paid hereunder to any such member shall not
18 exceed twenty-four hundred dollars in any calendar year.
19 The members of the board shall receive their traveling and
20 other necessary expenses incurred in the performance of their
21 duties. The director shall provide for the board suitable
22 quarters and such clerical and other assistance as the board
23 may deem necessary. Said offices and the incumbents thereof

24 shall not be subject to chapter thirty-one and the rules and 25 regulations made thereunder.
