### AN ACT FURTHER REGULATING WAGERING AT RACING MEETINGS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 10 of chapter 128A of the General Laws, as most  
2 recently amended by chapter 268 of the acts of 1936, is  
3 hereby further amended by striking out the first sentence and  
4 by inserting in place thereof the following sentence: —

5 “Any licensee knowingly permitting any person under  
6 eighteen to participate in the pari-mutuel or certificate system  
7 of wagering at a racing meeting held or conducted by such  
8 licensee shall be punished by a fine of not more than one  
9 hundred dollars.”
