## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Seventy-One.

AN ACT PROVIDING FOR FULL-TIME REPRESENTATION BY SOUTHEASTERN MASSACHUSETTS UNIVERSITY ON THE BOARD OF HIGHER EDUCATION.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 572 of the acts of 1965 is hereby amended by  
2 striking out the first paragraph of section 1A and inserting in  
3 place thereof the following: —  
4 *Section 1A.* There shall be in the department, but not sub-  
5 ject to its control, a board of higher education, in this section  
6 and in section one B, one C and one D, called the Board,  
7 consisting of a member of the board of trustees of the Univer-  
8 sity of Massachusetts, selected by majority vote of all of the  
9 members of said board; a member of the board of trustees of  
10 state colleges, selected by a majority vote of all of the mem-  
11 bers of said board; a member of the board of regional com-  
12 munity colleges, selected by majority vote of all the members  
13 of said board; a member of the board of trustees of Lowell  
14 technological institute, selected by majority vote of all the  
15 members of said board; and a member of the board of trustees  
16 of Southeastern Massachusetts University, selected by majority  
17 vote of all of the members of said board, each of said five  
18 members to serve for a term of one year, and six persons to be  
19 appointed by the Governor, one of whom shall be a member of  
20 the governing board of a private institution of higher education  
21 in the commonwealth, one of whom shall be a member of a  
22 labor organization affiliated with the Massachusetts State Labor  
23 Council, AFL-CIO, and at least two of whom shall be women.

It is the duty of the committee to report to the House the results of its investigations and to recommend such legislation as may be deemed necessary.
