AN ACT PROVIDING FOR PARTIAL REIMBURSEMENT BY THE COMMONWEALTH TO CITIES AND TOWNS WHICH PARTICIPATE IN TELEVISION EDUCATIONAL PROGRAMS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 13F of chapter 71 of the General Laws, as most
2 recently amended by chapter 567 of the acts of 1960, is
3 hereby amended by adding after the second sentence, the
4 following two sentences: — The state treasurer shall annually,
5 on or before November twentieth, reimburse each city or town
6 which has shared the cost of such programs, as evidenced by
7 the written agreement of each such city or town with the
8 executive committee for educational television, a sum equal to
9 fifty per cent of the total share paid by such city or town for
10 the then current fiscal year. Such reimbursement shall be subject
11 to annual appropriation and shall not exceed a total reimburse-
12 ment to the several such cities or towns of more than two
13 hundred fifty thousand dollars.
