### AN ACT RELATIVE TO THE RETIREMENT RIGHTS OF CERTAIN RETIRED VETERANS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1 Paragraph 2 of section 60 of chapter 32 of the General Laws
- 2 is hereby amended to include under sections 56 to section 59
- 3 inclusive, any veteran of World War II who has a wartime
- 4 service connected disability, and who has 30 years service with
- 5 the Commonwealth of Massachusetts and was permanently em-
- 6 ployed by the Commonwealth prior to his entry into the
- 7 armed forces of World War II.
