AN ACT TO AUTHORIZE THE DEPARTMENT OF PUBLIC HEALTH TO ESTABLISH GLAUCOMA CLINICS THROUGHOUT THE COMMONWEALTH.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 4 The Department may enter into whatever agreements with
- 5 community hospitals and other health, welfare, and rehabili-
- 6 tation agencies as are necessary to carry out the purpose of

Be it Enacted by the Senate and House of Representatives in General Session assembled, That the Department of Public Health be authorized to establish and maintain in the State of Massachusetts a system of public health clinics throughout the Commonwealth, and to authorize the Department of Public Health to hereby authorized, subject to the appropriation of such sums of money as may be necessary therefor, to carry out the purposes of this act.
