1 *Resolved*, That, subject to appropriation, there be allowed  
2 and paid from the state treasury, under the direction of the  
3 attorney general, to the heirs at law or next of kin of the late  
4 Tihon Prisiaznuk, alias Tihon Efremovich Prisiazhnuk, who  
5 died in the city of Peabody on March second, nineteen hundred  
6 and fifty-nine, or to their respective lawful representatives,  
7 such sum as may be found by the attorney general to have  
8 been paid into said treasury, as the balance of the assets  
9 belonging to the estate of Tihon Prisiaznuk, alias Tihon  
10 Efremovich Prisiazhnuk, under section ten of chapter one  
11 hundred and ninety-four of the General Laws, notwithstanding  
12 the expiration of the time limited by said section for the  
13 recovery of such sum.

By Mr. Gardner a portion of \$100,000 was provided for the
