SENATE, February 9, 1972.

1 *Ordered*, That a special committee, to consist of three
2 members of the senate to be designated by the president
3 thereof, is hereby established to investigate and study the
4 Youth Service Board, with particular emphasis on its manage-
5 ment, operation, programs, allocation and use of federal and
6 state funds.

7 Said committee shall be provided with quarters in the state
8 house or elsewhere; may expend for expenses and for expert,
9 legal, clerical and other assistance such sums as may be ap-
10 propriated therefor; may travel without and within the com-
11 monwealth; may sit during the recess of the general court;
12 may hold hearings; and may require by summons the at-
13 tendance and testimony of witnesses under oath and the
14 production of books, records and papers.

15 Said committee may report from time to time to the general
16 court the results of its investigation and study and its recom-
17 mendations, if any, together with drafts of legislation neces-
18 sary to carry its recommendations into effect by filing the
19 same with the clerk of the senate, but shall file its final report
20 on or before the last Wednesday of December, nineteen hun-
21 dred and seventy-two.
