AN ACT PROVIDING REAL ESTATE TAX EXEMPTIONS FOR WIDOWS OF THE VIETNAM VETERANS AND PERSONS MISSING IN ACTION.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 5 of chapter 59, as most recently amended by sec-  
2 tion 10 of chapter 1110 of the acts of 1971, is hereby further  
3 amended by adding after clause forty-second the following  
4 clause:

5 *Forty-second A*, Real estate of the wife or widow until she  
6 remarries, of soldiers or sailors who lost their lives in combat  
7 as members of the armed forces of the United States during  
8 the Vietnam campaign or are listed as missing in action as a  
9 result of service during said Vietnam campaign, to the amount  
10 of eight thousand dollars or the sum of seven hundred dollars;  
11 whichever would result in an abatement of the greater amount  
12 of actual taxes due provided that such real estate is owned, and  
13 occupied by her as her domicile, and provided, further, no real  
14 estate shall be so exempt which the assessors shall adjudge  
15 has been conveyed to such widow to evade taxation.
