AN ACT TO AMEND THE CONSTITUTION OF THE STATE OF MICHIGAN

SECTION 1. The Constitution of the State of Michigan is amended to read as follows:
Article I, Section 1. The legislative power shall be vested in the Senate and House of Representatives, which shall be styled the Legislature of the State of Michigan.

SECTION 2. The Constitution of the State of Michigan is amended to read as follows:

Article II, Section 1. The executive power shall be vested in the Governor of the State of Michigan.

SECTION 3. The Constitution of the State of Michigan is amended to read as follows:

Article III, Section 1. The judicial power shall be vested in the Supreme Court of the State of Michigan.

SECTION 4. The Constitution of the State of Michigan is amended to read as follows:

Article IV, Section 1. The power of taxation shall be vested in the Legislature of the State of Michigan.

SECTION 5. The Constitution of the State of Michigan is amended to read as follows:

Article V, Section 1. The power of eminent domain shall be vested in the Legislature of the State of Michigan.

SECTION 6. The Constitution of the State of Michigan is amended to read as follows:

Article VI, Section 1. The power of pardon shall be vested in the Governor of the State of Michigan.
