AN ACT AUTHORIZING THE DISTRICT ATTORNEY FOR THE PLYMOUTH DISTRICT TO APPOINT A MESSENGER.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 22 of Chapter 12 of the General Laws, as most re-
2 cently amended by Chapter 423 of the Acts of 1948, is hereby
3 further amended by inserting after the last sentence of Section
4 22, the following new sentences: —

5 The district attorney for the Plymouth District may also
6 appoint a messenger. The compensation for any person ap-
7 pointed hereunder shall be paid by Plymouth county, and any
8 such person appointed may be removed by said district at-
9 torney at his pleasure.
