AN ACT FURTHER DEFINING A PERIOD OF SILENCE IN ALL PUBLIC SCHOOLS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 The first paragraph of Section 1A of Chapter 71 of the
- 2 General Laws is hereby amended by striking out the first sen-
- 3 tence and inserting in place thereof the following sentence: —
- 4 At the commencement of the first class of each day in all
- 5 grades in all public schools the teacher in charge of the room
- 6 in which such class is held shall announce that a period of
- 7 silence not to exceed one minute in duration shall be observed,
- 8 and during any such period silence shall be maintained and no
- 9 activities engaged in.
