AN ACT AUTHORIZING THE TOWN OF EAST BRIDGEWATER TO APPOINT A TREASURER/COLLECTOR AND TO AUTHORIZE THE TREASURER TO ACT AS COLLECTOR.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 The Board of Selectmen, the Chairman of the Finance Commit-
2 tee and the Moderator of the Town of East Bridgewater,
3 commencing after the Annual Town Election for the year 1989,
4 notwithstanding the provisions of M.G.L. Chapter 41, Section 1,
5 shall appoint a Treasurer/Collector for a term of three (3) years,
6 and further that the Treasurer be authorized to act as Collector of
7 Taxes; said Treasurer/Collector to take oath and be qualified to
8 serve until such time as a successor is appointed and qualified.

9 Further, if the office of Treasurer or Collector of Taxes shall
10 become vacant before implementation of the appointment of a
11 Treasurer/Collector, the Board of Selectmen shall be authorized
12 to appoint a temporary Treasurer or Collector who shall serve until
13 such time as the Treasurer/Collector has been appointed and
14 qualified.
