## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Eighty-Seven.

AN ACT RELATIVE TO THE LICENSING FEES FOR RESIDENTS AND NON-RESIDENTS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION. 1. Section 83 of Chapter 130 of the General Laws  
2 is hereby amended by striking out section 230 of Chapter 572 of  
3 the Acts of 1980 and replacing it with the following new section: —  
4 Section 83. For the purpose of defraying the cost of the  
5 division's research, management and other activities including  
6 administrative and operating expenses, and the cost of issuing the  
7 following resident and non-resident permits and the inspection  
8 relative thereto, resident and non-resident fees, the amounts which  
9 shall be determined by the secretary of administration and finance  
10 under the provisions of section three B of chapter seven for the  
11 filing thereof, shall be paid to the director by the person to whom  
12 the same is issued for any calendar year or part thereof.

1 SECTION 2. Section 80 of Chapter 130 of the General Laws  
2 as most recently amended by Section 2 of Chapter 422 of the acts  
3 of 1971 is hereby further amended by striking out the last sentence  
4 of the first paragraph and replacing it with the following new  
5 sentence: — Notwithstanding any contrary provision as  
6 contained in this section, a person who has in his possession a  
7 commercial fisherman permit (rod and reel) may take by rod and  
8 reel or by diving and sell finfish lawfully taken from the coastal  
9 waters.
