AN ACT RELATIVE TO REAL PROPERTY TAX ABATEMENTS FOR CERTAIN VETERANS WITH A SERVICE-CONNECTED DISABILITY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. The first paragraph of clause twenty-second of
- 2 section 5 of chapter 59 of the General Laws, as appearing in section
- 3 2 of chapter 1110 of the acts of 1971, is hereby amended by striking
- 4 out, in lines 13 and 14, the words "one hundred and seventy-five"
- 5 and inserting in place thereof the words: three hundred and fifty.
- SECTION 2. The first paragraph of clause twenty-second A of
- 2 said section 5 of said chapter 59, as appearing in section 5 of said
- 3 chapter 1110, is hereby amended by inserting after the word
- 4 "cross", the second time it appears, in line 19, the words "or who
- 5 according to the records of the Veterans Administration is receiving
- 6 a service connected disability of at least thirty per cent to sixty per
- 7 cent", and by striking out, in line 20, the words "three hundred and
- 8 fifty" and inserting in place thereof the words: seven hundred.
- SECTION 3. The first paragraph of clause Twenty-Second B of 2 said section 5 of said chapter 59, as appearing in section 6 of said
- 3 chapter 1110, is hereby amended by inserting after the word
- 4 "Administration", in line 16, the words, "or who according to the
- 5 records of the Veterans Administration is receiving a service con-
- 6 nected disability of over sixty per cent", and by striking out, in line
- 17, the words "seven hundred" and inserting in place thereof the
- 8 words: one thousand four hundred.

- 1 SECTION 4. The first paragraph of clause Twenty-second C of 2 said section 5 of said chapter 59, as appearing in section 7 of said 3 chapter 1110, is hereby amended by striking out, in line 14, the 4 words "eight hundred and seventy-five" and inserting in place
- 4 words "eight hundred and seventy-five" and inserting in place 5 thereof the words: —one thousand seven hundred and fifty.
- I SECTION 5. The first paragraph of clause Twenty-second D of 2 said section 5 of said chapter 59, as appearing in section 8 of said
- 3 chapter 1110, is hereby amended by striking out, in line 2, the words
- 4 "one hundred and seventy-five" and inserting in place thereof the
- 5 words: four hundred.
- 1 SECTION 6. The first paragraph of clause Twenty-second E of
- 2 said section 5 of said chapter 59, as appearing in section 3 of chapter
- 3 831 of the acts of 1974, is hereby amended by striking out, in lines 10
- 4 to 12, inclusive, the words "six thousand dollars or the sum of five
- 5 hundred and twenty-five dollars, whichever would result in an
- 6 abatement of the greater amount of actual taxes due" and inserting
- 7 in place thereof the words: the total amount of actual taxes due.
- 1 SECTION 7. Section 8A of chapter 58 of the General Laws, as
- 2 most recently amended by section 38 of chapter 514 of the acts of
- 3 1978, is hereby further amended by inserting after the word "veter-
- 4 an", in line 4, the words: —, or a veteran, as defined in clause
- 5 Twenty-second E of section five of chapter fifty-nine, or the surviv-
- 6 ing widow of such veteran,.
