AN ACT AMENDING THE CITY CHARTER OF THE CITY OF HOLYOKE.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

5 III. A city solicitor, to be confirmed by the board of aldermen.  
6 Should the board of alderman fail to confirm the appointment  
7 or reappointment of the city solicitor, the assistant city solicitor  
8 will assume the duties of the city solicitor until an appointment  
9 of a city solicitor is confirmed.
