AN ACT CLARIFYING THE SCOPE OF THE AUTHORITY OF THE BOARD OF FIRE PREVENTION REGULATIONS IN PROMULGATING THE SO-CALLED MASSACHUSETTS ELECTRICAL CODE.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 3L of chapter 143 of the General Laws,  
2 as appearing in the 1984 Official Edition is hereby amended by  
3 striking out the first sentence and inserting in place thereof the  
4 following sentence: — The board of fire prevention regulations  
5 shall make and promulgate and from time to time may alter,  
6 amend and repeal, rules and regulations relative to the  
7 installation, repair and maintenance of electrical wiring in or  
8 supplied from buildings and structures subject to the provisions  
9 of chapter 143 of the General Laws, and the state building code.

1 SECTION 2. Amend Section 3L of Chapter 143 of the General  
2 Laws as appearing in the 1984 Official Edition by adding at the  
3 end thereof the following new paragraph: —

4 Nothing in the two preceding paragraphs of this section shall  
5 apply to wires, fixtures or equipment of companies incorporated  
6 for the transmission of intelligence by electricity, their affiliates  
7 or subsidiaries, in installing, maintaining or repairing wires used  
8 by such companies, their affiliates or subsidiaries and necessary  
9 for or incidental to their communications business whether or not  
10 such wires are on its or their own premises.

1 SECTION 3. Section 32 of Chapter 166 of the General Laws  
2 is hereby amended by adding in the fourth sentence after the words  
3 “building code commission” the following: — “and except wires  
4 of companies incorporated for the transmission of intelligence by  
5 electricity, their affiliates or subsidiaries necessary for or  
6 incidental to their communications business whether such wires  
7 are on its or their own premises.”
