AN ACT AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TO GRANT LICENSES FOR THE CONSTRUCTION, EXTENSION AND MAINTENANCE OF A PIER IN GLOUCESTER HARBOR AND SMITH COVE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The department of public works is hereby au-
2 thorized, notwithstanding any provision of section fourteen of
3 chapter ninety-one of the General Laws, to grant licenses for
4 the extension and maintenance of two existing piers, extending
5 in an easterly direction into Smith cove in the city of Gloucester
6 beyond the harbor line established by chapter one hundred
7 and twenty-four of the acts of eighteen hundred and sixty-six,
8 such extension not to exceed twenty-five feet.

1 SECTION 2. The department of public works is hereby au-
2 thorized, notwithstanding any provision of section fourteen of
3 chapter ninety-one of the General Laws to grant licenses for
4 the construction and maintenance of a pier extending in a
5 Northeasterly direction into Gloucester Harbor in the city of
6 Gloucester at the Rocky Neck Railways beyond the harbor line
7 established by chapter one hundred and twenty-four of the acts
8 of eighteen hundred and sixty-six, said pier not to exceed one
9 hundred feet in length.
