AN ACT PROVIDING FINANCIAL ASSISTANCE BY THE COMMONWEALTH TO CITIES AND TOWNS FOR THE PREPARATION AND COMPLETION OF COMMUNITY RENEWAL PROGRAMS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 121 of the General Laws is hereby amended by add-
2 ing the following new section:—

3 *Section 26000.* The commonwealth, acting by and through
4 the department of community affairs, may contract with any
5 city or town in the commonwealth to make grants for the
6 preparation and completion of a community renewal program
7 in such city or town under Title I of the Federal Housing Act
8 of 1949 as amended.

9 No grant made to any city or town pursuant to this section
10 shall exceed the lesser of one half the amount provided by such
11 city or town for such purpose, or one sixth of the net total cost
12 as such cost is determined by the said division of urban renewal
13 for the preparation or completion of such program.

14 No contract for a grant or assistance pursuant to this section
15 shall be made unless the city manager, with the approval of the
16 city council in a city having a Plan D or Plan E charter, in any
17 other city, by the mayor with the approval of the city council
18 or the selectmen of a town shall have approved the preparation
19 or completion of the community renewal program.

20 The total amount of community renewal assistance grants to
21 be paid under the provisions of this section shall not exceed one
22 million dollars.
