AN ACT TO PERMIT THE CANCELLATION OF SALES CONTRACTS MADE BY DOOR-TO-DOOR SALESMEN WITHIN THREE BUSINESS DAYS OF THE SALE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 When, there not having been receipt or tender of a substantial
2 part of the goods, services, or goods and services which the
3 seller is required to furnish under a retail installment sale
4 agreement, signed by the seller, which has been consummated
5 by a party thereto at a place other than the address of the seller,
6 which may be his main office or branch thereof, the buyer, not
7 later than five o'clock postmeridian on the third business day,
8 notifies the seller that he is cancelling, and such cancellation
9 shall be effective thereupon.
