## The Commonwealth of Massachusetts

### AN ACT RELATIVE TO AMENDING CO-OPERATIVE BANK COMMON FORM MORTGAGE LOANS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Paragraph 3 of section 23 of chapter 170 of the General  
2 Laws is hereby amended by striking out said paragraph 3  
3 and inserting in place thereof the following paragraph:—  
4 3. *Common Form Mortgage Loans.* Each loan hereunder  
5 shall be for an amount not in excess of eighty per cent of  
6 the value of the real estate securing the loan and for a term  
7 not in excess of five years; provided, that during such time  
8 as the principal balance is in excess of seventy per cent of  
9 such value, the terms of the note and mortgage shall require  
10 fixed monthly or quarterly payments in substantially the  
11 same amount, which payments shall first be applied to  
12 interest on the balance of the loan and thereafter applied  
13 to principal; provided, further, that each payment of interest  
14 and principal shall not be less than would be sufficient to  
15 amortize the loan over a period of twenty-five years. The  
16 aggregate principal balance of loans hereunder originated by  
17 such corporation, not including those converted from other  
18 types, shall not at any one time be made to exceed twenty-  
19 five per cent of its assets.
