AN ACT PROVIDING A CREDIT OF FIVE ADDITIONAL YEARS FOR ANY MEMBER OF THE RETIREMENT SYSTEM ATTAINING TWENTY-FIVE OR MORE YEARS OF CREDITABLE SERVICE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

2 as most recently amended by section 1 of chapter 190 of the

4 graph (d) the following paragraph:—

5 (e) Any member attaining twenty-five years or more of
6 creditable service shall upon retirement be entitled to a credit
7 of five additional years which shall be added to earned creditable
8 service in computing his retirement allowance.
