AN ACT AUTHORIZING AND DIRECTING THE METROPOLITAN DISTRICT COMMISSION TO TRANSFER OPERATIONAL CONTROL OF FRANKLIN PARK ZOO TO PRIVATE MANAGEMENT.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1 The metropolitan district commission is hereby authorized
- 2 and directed to transfer operational control of the Franklin
- 3 Park Zoo located in the Mattapan section of the city of

- 5 The commission shall make such transfer only on the
- 6 basis of a contract containing specifications that shall not
- 7 only save the commonwealth and its employees harmless

- 10 commission deems it feasible, it shall submit the contract for
- 11 open bidding, otherwise it shall take whatever action it con-
